

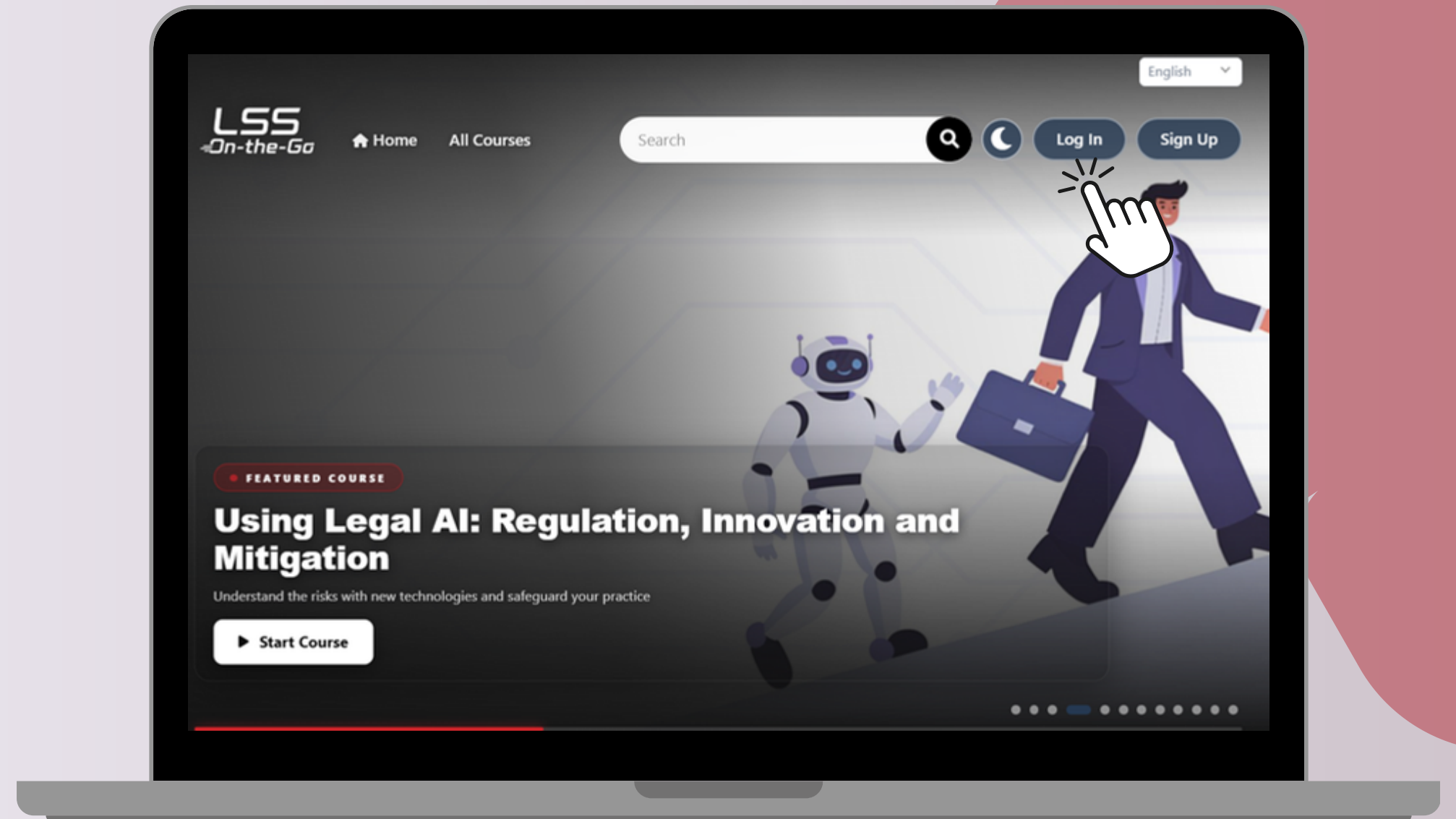

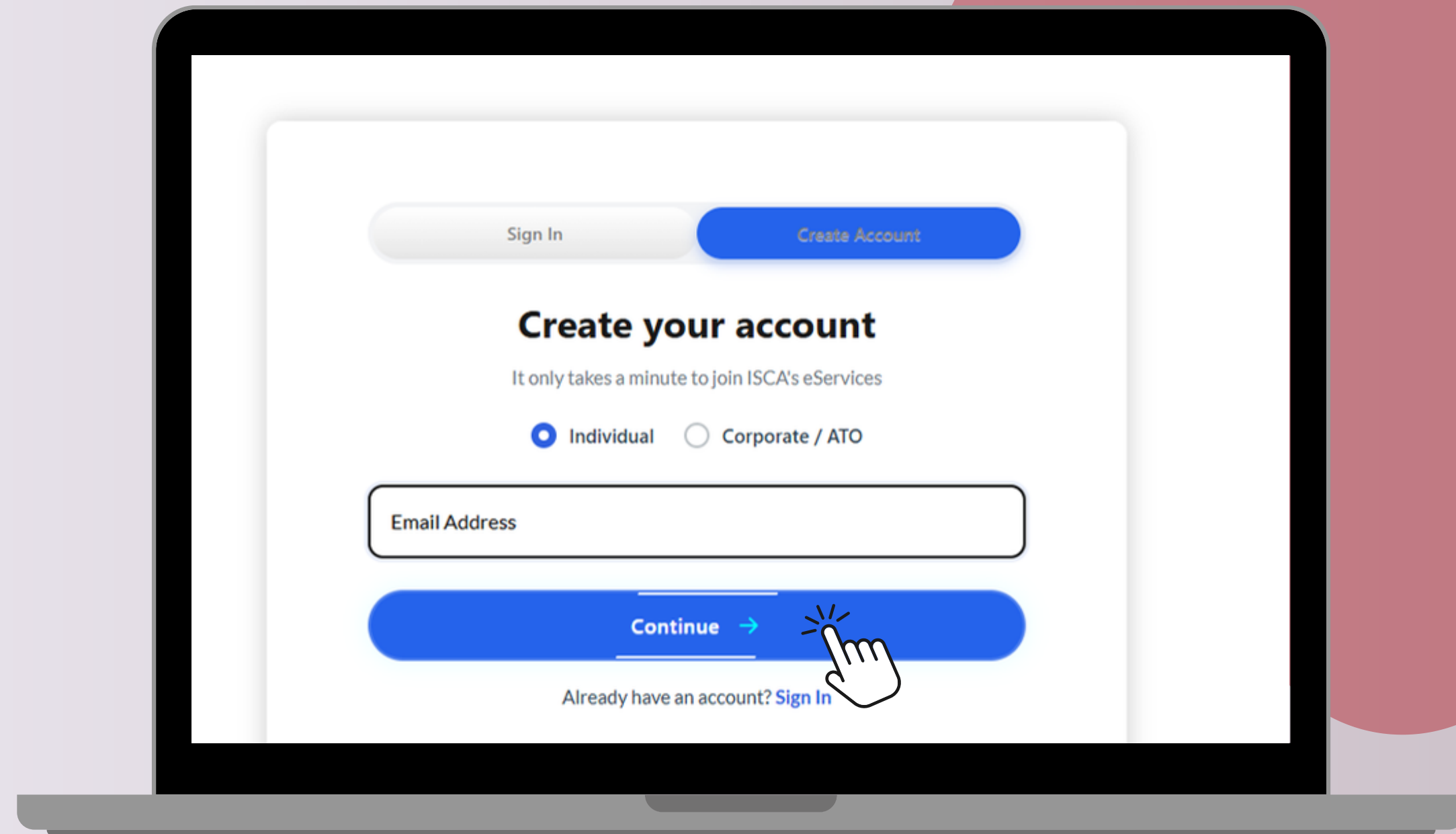

Click “**Continue**” to proceed.

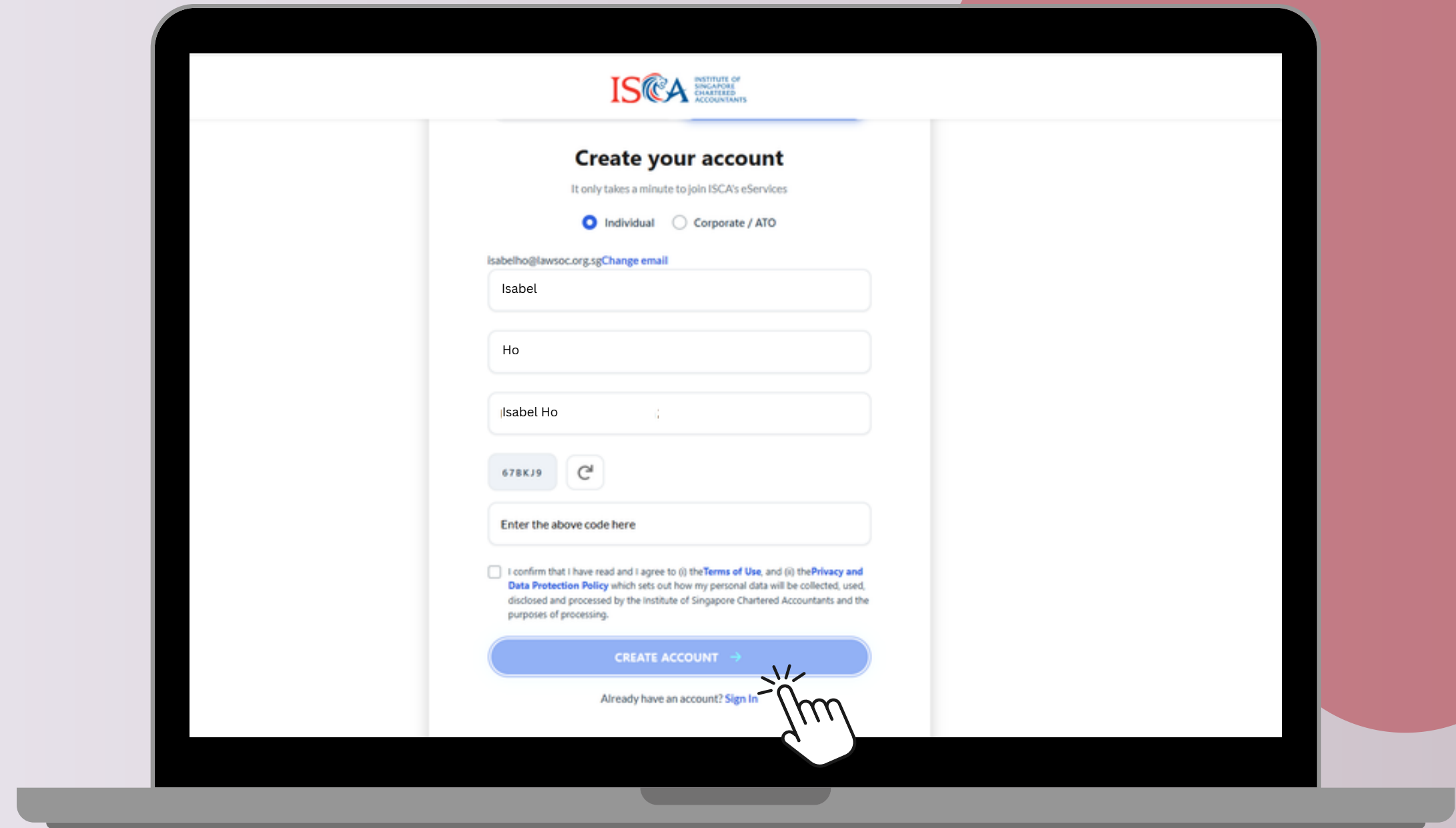

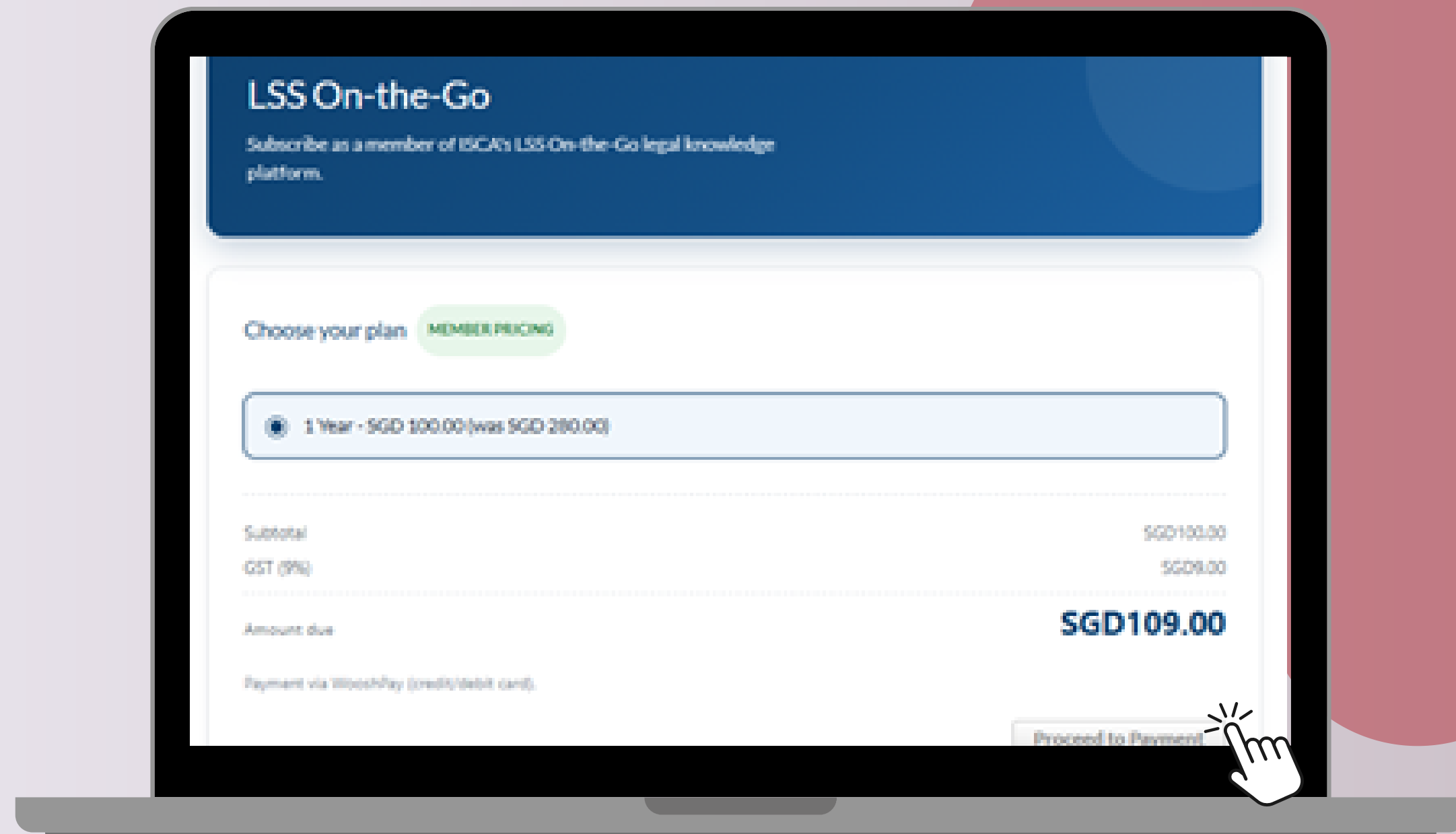

Click ‘**Proceed to Payment**’ and follow the instructions to make payment.



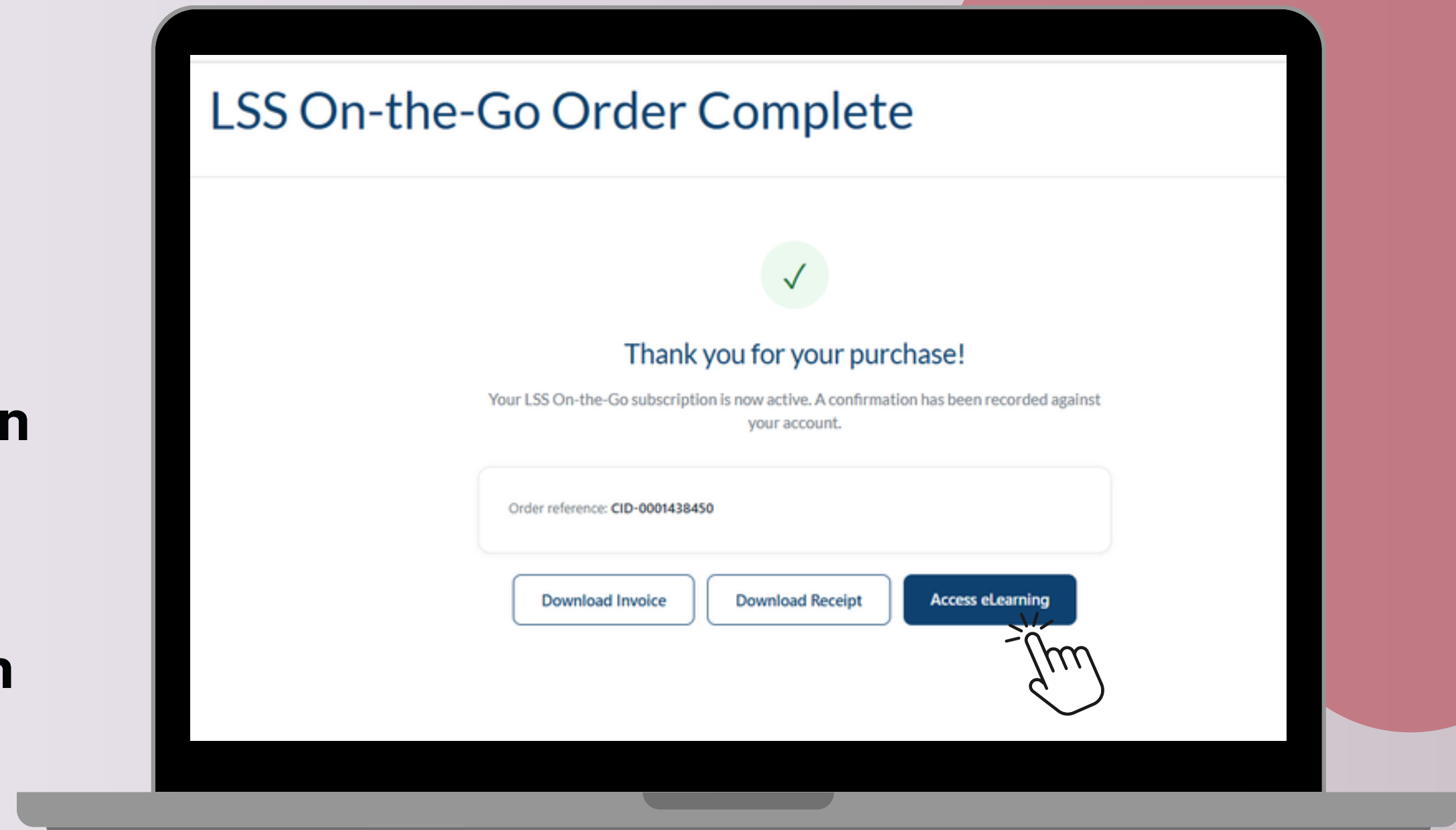
